SUBJECT: New Form 15675 for submission of sensitive case reports

This memorandum serves as interim guidance to provide for the use of Form 15675, SB/SE Division Sensitive Case Report, when submitting case information to leadership on potentially sensitive tax cases. Please distribute this information to all affected employees in your organization.

Purpose: The purpose of this memorandum is to issue procedural guidance and provide for the usage of Form 15675 when submitting sensitive cases to the executive.

Background: IRM 1.4.50.11.10 discusses sensitive case reports (SCRs). Sensitive case reports are used to notify leadership of investigations of high-profile taxpayers, or instances where a planned enforcement action will have a broad impact on the welfare of third parties. The reports serve as a situational awareness of such cases for leadership's preparedness for potential Congressional inquiries or media attention. High-profile taxpayers include well-known entertainers, national sports figures, prominent political figures and state or large municipal governments.

Procedural Change: SB/SE Supervisory Revenue Officers will generate the Form 15675, SB/SE Division Sensitive Case Report, from the Published Products Catalog when submitting case information to leadership on potentially sensitive tax cases.

Effect on Other Documents: This guidance will be incorporated into IRM 1.4.50, Collection Group Manager, Field Compliance Manager and Area Director Operational Aid within 2 years from the date of this memorandum.

Effective Date: This guidance is effective from the date of this memorandum.
