IRS Chief Counsel (CC) has a legal obligation to track and maintain litigation holds in order to preserve potential evidence for court and other proceedings. The IRS CC Litigation Hold solution is an internal database that keeps track of both IRS and CC employees who are subject to a litigation hold because a matter that the employee worked on is subject to litigation, a Congressional or TIGTA investigation, or because the matters may be subject to future litigation or investigation. The purpose of a litigation hold is to suspend the normal retention rules regarding the disposition or processing of records to ensure such records are preserved for use in litigation. Implementing these litigation holds helps the Service meet its legal requirements under the Federal Rules of Civil Procedure and helps prevent relevant evidence from being inadvertently destroyed due to routine record retention policies. After the issuance of a litigation hold by Chief Counsel, certain information regarding the employee subject to the hold is added to the IRS CC Litigation Hold application by Chief Counsel. This information includes the litigation hold issue date, the employee's full name, the employee's

SEID, the case name, the assigned Chief Counsel attorney, the business unit of both the CC attorney and the employee subject to the litigation hold, and the internal CASE-MIS number. The IRS CC Litigation Hold application is a system that may be queried by its users and the system is limited to use by only Chief Counsel employees. The solution will use a Power App template form and Dataverse tables to intake information from Users about new litigation holds.
