Taxpayer Services' 2024 Stakeholder Partnerships, Education and Communication (SPEC) Partners Survey continues to support the delivery of free tax return preparation, outreach and education for taxpayers by operating more than 12,000 Volunteer Income Tax Assistance (VITA) and Tax Counseling for the Elderly (TCE) sites; this effort was instituted in 2003 and continues to evolve; it supports IRS' Strategic Goal I (Service) "Deliver high quality and timely service to reduce taxpayer burden and encourage voluntary compliance." As a SPEC member, the targeted audience, they are asked during events or in form submissions if they would like to self-identify themselves as a potential participant for future survey projects. They are notified by IRS' contractor [Pacific Consultation Group, PCG] that will be electronically transferred to secure environment for extraction and updates. IRS maintains the contact list to communicate SPEC events and survey opportunities. Therefore, there is no applied methodology for selection; the tax professionals that indicates voluntary participation in a focus group are automatically eligible. The purpose and results

of this survey helps determine two external performance measures: 1) SPEC Partner satisfaction; and 2) SPEC Partner dissatisfaction. These satisfaction measures help SPEC plan actions to meet SPEC Partner needs and improve SPEC products and services to taxpayers. Contractor will have access to the data and sent to the service via Enterprise File Transfer Utility (EFTU). Only the aggregated survey results data will be shared by the contractor to Taxpayer Service's SPEC Office; no responses, specific to an individual, will be captured or used for any reason other than declared within this PCLIA. The aggregated data will include issues identified during each of the sessions; services used, how well the services worked, the user's authentication experience, and areas of improvement such as additional services; the results will be shared with TAS management

SPEC uses PII during the selection process; a list of partner names and e-mails is used to send an invitation to the survey. Although, the data (the partner listing) is stored within SPECs secure environment, even if the Partner does not respond to the survey; no association to the individual is made whether they participate or not and therefore cannot be disclosed.

The linkable items identified are used to select and notify participants; they are address, name, email address, employment information, other, and state. Other is defined as external organization membership information and/or organization title; these elements are used for selection and notification purposes.

There is no applied participant selection process; all SPEC partners are the targeted participant and are eligible to participate based on their SPEC membership. They opt-in by voluntarily indicating their willingness to participate in a future survey (each SPEC has a partner agreement (Form 13533) that is signed each year with a line asking for the email address of the contact to take the survey). We do not have a research plan; this is a means to receive direct feedback from our customers specific to their experience with IRS' products and services. SPEC is providing a SPEC partner listing of all SPEC partner's that have a survey contact identified in SPEC's MIS system SPECTRM (SPEC Total Relationship Management). The listing includes organization name, e-mail contact information, partner type, and other needed information. SPEC transfers the listing to contractor (Pacific Consulting Group; PCG) as a secured, encrypted, and zipped electronic file via the IRS Enterprise File Transfer Utility (EFTU) process. The list is available to IRS personnel connected to the project and the contractor. Email addresses are used for contact only and cannot be connected to any given SPEC Partner's responses. The contractor shall send a pre-notification e-mail to SPEC Partners notifying them of the upcoming survey. Hyperlinks will be disabled in the email, and no replies are allowed to the email. The contractor shall capture opt-outs, contact information changes, and e-mail addresses from data collection attempts returned as undeliverable. This information will be shared

with the Taxpayer Services (TS) Contracting Officer Representative (COR), SPEC representative and TS survey researcher/s on a weekly basis via e-mail. The IRS will attempt to locate correct e-mail addresses for partners whose e-mails were returned undelivered. To locate correct e-mail addresses, SPEC Headquarters will work with SPEC Relationship Managers to contact SPEC Partners to obtain the correct contact information for these Partners.

There is no applied participant selection process; all SPEC partners are the targeted participant and are eligible to participate based on their SPEC membership. They opt-in by voluntarily indicating their willingness to participate in a future survey (each SPEC has a partner agreement (Form 13533) that is signed each year with a line asking for the email address of the contact to take the survey). Participants (SPEC Partners) will receive a pre-survey notification e-mail notifying them of the upcoming survey; this notice will include a privacy notice letting them know the date and purpose of the survey, what information we will collect and that their responses are voluntary and no adverse actions by not participating. We do not have a research plan; this is a means to receive direct feedback from our customers specific to their experience with IRS' products and services.

The contractor uses Qualtrics, a FedRAMP certified, data-collection survey tool to create and conduct the survey. The anonymous feature is set for the survey.

All data is required to be segregated from other non-IRS data. In addition, all data at rest or in transport must be encrypted. Whenever information is stored on IT assets at the facility, the contractor must be compliant with the implementation of NIST 800-53, Recommended Security Controls for Federal Information Systems & Organizations controls.

4.23 Where and how is the PII stored and protected?

SBU/PII used in SPEC's pre-survey activities is limited to two sets of data; the participant listing is extracted from IRS' SPEC system and temporarily stored in the EFTU tool. This data will form a working participant list; both the contractor and the IRS will make updates throughout the project's lifecycle. The second data set is the notification of the survey or survey communication templates. The survey templates used to provide the notice of survey, including reminders and thank you's, will be stored by both the Project Office and Contractor in a secure environment with limited or restricted access; access is granted only to the working project team. The email invite will be stored in the contractor's secure email environment and retained per industry standards and as declared in this PCLIA. This survey administration does not request nor anticipate the use of PII other than the elements declared for participant contact, i.e. the participant's name (first and last), e-mail and mailing address, state, and their organizational information). The eGovernment reporting requirements dictates raw responses will be captured and shared to Office of Management and Budget; however, any PII that identifies a person will be redacted prior to being stored/transmitted; this promotes disassociation from the individual and their response. During the last phase or post-survey activities the use of SBU/PII is not required. All survey results will be aggregated; any PII that identifies a person will be redacted prior to being transmitted/stored in SPECs secure environment. As indicated in the Records Section, retention of this survey's data will be retained for one year passed the project's resolution or when no longer needed.

The contractor, as the survey administrator, protects the participants' data by temporarily transmitting the listing to a secure electronic file transfer tool; the aggregated reports do not contain PII; this ensures the responses cannot be associated to the individual. The Applied controls as indicated in the Publication 4812 are adhered to; a separation of duties and data and limited access is granted based on assigned duties. The data is stored on a secured shared drive with limited access.

To ensure survey results are not used for any other purpose than identified in this PCLIA, the contractor will not share "raw" survey results outside of the IRS; information that can identify an employee or taxpayer is deleted from the data that is retained by the administrator/vendor [Pacific Consulting Group (PCG)] as identified in the Records section of this PCLIA. Deliverables will be sent to the business unit with aggregated data only; no PII Specific to an individual is included when shared to SPEC; there is no means to reidentify or associate a response to an individual; therefore, there is no means to take adverse action. For transfer of potential participants contact information or survey results in aggregated form, and OMB reporting only Approved Cyber Security and National Institute of Standards and Technology (NIST) requirements will used to transfer/transmit data, i.e. data will be password protected. The participant data is electronically transferred to and from the contractor using the Electronic File Transfer Utility tool (EFTU) as a bulk data file; file encryption and an encryption

phrase are communicated separately from the email/package is applied as a precaution. An alternate method to communicate the pass phrase, e.g., phone call will also be used facilitate access to the data. Aggregated data/reports are sent to the Business Unit (BU); the survey results are destroyed at the end of the contract. Although EFTU and SecureZip are preferred, currently all methods are being used.

PCG currently owns and maintains an annual subscription to Qualtrics' FedRAMP approved services which is used in support of SPEC-Partner surveys. Licenses used are owned and operated by a small number of PCG staff who all currently hold staff-like access.
