The Direct File Customer Experience Survey will help fulfill the Inflation Reduction Act (IRA) requirement to design systems informed by "taxpayer opinions, expectations, and level of trust." The survey will provide insights about taxpayers' behaviors, attitudes, and needs. The results of this survey will enable the IRS to gain insights into what is and isn't working well and to make continuous changes to improve taxpayer experiences. The online survey is being conducted by the IRS Direct File research team, which includes staff from IRS Direct File, US Digital Service, and Coforma. The survey will be implemented by Medallia contractor using the Medallia survey tool. The survey will be with external individual taxpayers who have experience using Direct File. For users who complete their filing with Direct File, there will be a button on the submission confirmation page inviting them to provide feedback. If they click, they will be able to open the survey and give feedback voluntarily. For users who opt into receiving a survey by email and do not finish their filing with Direct File, IRS Direct File team will email them a link to the survey after the end of filing

season. Information collected in the survey includes email, phone number, income, previous year's tax filing method, education level, zip code, device type used to access survey. Only the Direct File research team and Medallia staff working on the project will have access to the raw data, which will be stored on Medallia's secure servers.

Non-completion survey - Users who opt into receiving a survey by email and who do not file by end of filing season will receive a survey by email. If the user clicks the link to the survey, the survey will open. Respondents who opt to provide their email or phone number to provide additional feedback will be contacted by the research team for open-ended interviews.

For the completion survey, participants are notified via text on the screen of the survey availability. For the non-completion survey, participants are notified via email about the survey. All project information is stored on secure servers. Researchers performing analysis will have access to the raw data, but no raw data will be shared in reports to the requesting business unit.

Medallia stores information on secure servers with access provided only to select staff working on the project.

Contractors store information on secure servers with access provided only to select staff working on the project. Medallia provides Direct File researchers and Medallia administrators access to the survey PII via the Medallia dashboard. A unique username and password is required by each person to access the dashboard. The dashboard is hosted on Medallia secure servers and will be accessed by Direct File researchers and Medallia, before, during and after the survey.

PII raw data will not be shared with the requesting business unit. All reporting to business unit and stakeholders will have aggregate information and no respondents will be identified by PII.

Medallia contractors have administrator access to data. Coforma contractors part of the Direct File research team will have read only access to data for analysis. Background investigations are complete for contractors.
