- File Form 8872 immediately. If you expect contributions or expenditures over \$50,000 or less, you can file electronically at www.irs.gov/polorgs or mail your form to the address above.

Use the username and password we assigned you when you filed your initial Form 8871 and Form 8453-X, Political Organization Declaration for Electronic Filing of Notice 527 Status. If you've lost or forgotten your username or password, indicate this on the Response form.
